



## DEOCS Portal: How to Use the Registration Portal

July 2023

The *Defense Organizational Climate Survey (DEOCS)* is a tool that provides commanders and other Department of Defense (DoD) leaders with important feedback about the current climate within their unit or organization. This guide provides survey administrators with instructions on accessing and registering a *DEOCS*.<sup>1</sup>

## How to Register a New Survey in the DEOCS Portal

This section provides survey administrators with step-by-step instructions to register their DEOCS.<sup>2</sup>

### Enter DEOCS Request Details

To access the DEOCS Portal, follow these steps:

- **Step 1 – Log in to the DEOCS Portal [here](#).** Please use Google Chrome, Mozilla Firefox, Microsoft Edge, or Apple Safari. Internet Explorer is not a supported browser at this time.

- **Step 2 – Select “Create New Survey Request.”**

- **Step 3 – If the roster for this DEOCS request is classified, click to view the special instructions for classified rosters.**
  - If the roster is not classified, skip to Step 5.

To register your DEOCS, you must fill out all required fields and select the Register button located at the top of the page. Once you select Register, your survey will automatically be sent to your unit commander or organization leader who must review and approve the survey. After your commander or organization leader approves the survey, you will receive an email with further instructions. You can also select Save as Draft and return to fill out the remaining information at any time.

- **Step 4 – Review the instructions for classified rosters.**
  - If applicable to the unit or organization requesting the DEOCS, click the check box and then click “Confirm.”
  - If not applicable to the unit or organization requesting the DEOCS, click “Cancel.”

Classified Rosters

Per guidance from the Human Capital Management Office in the Office of the Under Secretary of Defense for Intelligence & Security, in most cases, unit rosters are not classified. Units in the Intelligence Community or other units with sensitive personnel assigned may use information found in the Defense Civilian Personnel Data System (DCPDS) and other DoD unclassified business systems to create DEOCS rosters.

If you have personnel in your unit whose identity is classified that are not in DCPDS or other DoD unclassified business systems, you may opt to administer a completely anonymous DEOCS by checking the box below. When you check this box:

- You will not be required to upload a roster.
- You have the option to indicate if you would like subgroups.
- You will indicate the number of people in your unit and each subgroup, if applicable.
- You will receive a single password for the entire unit, or each subgroup if applicable, that you will need to distribute.

- **Step 5 – Enter the Registration Name.**

- The registration name defaults to the survey administrator’s last name and current date (example: “Smith 08.15.2023”). Users can also create a unique name for their *DEOCS*.
- The registration name will be saved in the *DEOCS* Registration Portal and will act as an identifier for this *DEOCS* administration.

- **Step 6 – Select “Save as Draft.”**

- Survey administrators should save their registration regularly. Any work saved will remain available in the system if the user is either intentionally or accidentally logged out of the *DEOCS* Portal.

- **Step 7 – Upload *DEOCS* Participant Roster.**

- Click “Browse” underneath participant import and locate the roster or drag and drop the file into the space provided.
- All *DEOCS* requests require a roster of all individuals who are eligible to participate in the unit’s/organization’s *DEOCS*. This roster identifies all unit or organization participants that should receive a *DEOCS*.<sup>3</sup>

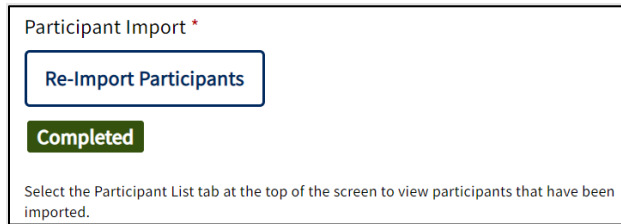

- **Step 8 – Select “Start Import” button.**

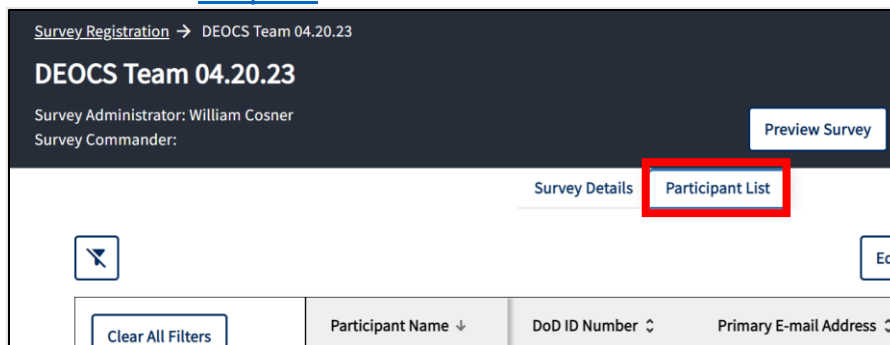
- If the roster did not contain any formatting errors, a green “Completed” message will be displayed underneath the “Participant Import” section.



- If the roster import was unsuccessful, follow the instructions in the error message to correct the roster and re-upload. Common errors include:
  - **Duplicate DoD ID, e-mail address, or phone number.** Ensure that all participants have unique DoD IDs, e-mail addresses, or phone numbers.
  - **Missing DoD ID, e-mail address, or phone number.** Ensure that a DoD ID, e-mail address, or phone number is listed for each participant.
  - **Fewer than five participants per subgroup.** Ensure that each subgroup contains at least five participants.
  - **Missing participant name.** Ensure that all participants have both a first and last name assigned to the appropriate rows.
  - **Invalid e-mail address.** Ensure that the e-mail address is properly formatted and that there are is not an extra space at the end of the address.
  - **Invalid header rows.** Ensure that each header row matches those in the roster template.<sup>4</sup>

- **Step 9 – Select “Participant List” to verify the roster accuracy.**

- Once the roster import is successful, click on the “Participant List” tab to verify the information uploaded looks correct.

- **Step 10 – Select “Survey Details.”**

To register your DEOCS, you must fill out all required fields and select the Register button located at the top of the page. Once you select Register, your survey will automatically be sent to your unit commander or organization leader who must review and approve the survey. After your commander or organization leader approves the survey, you will receive an email with further instructions. - **Step 11 – Select the Service Component.**

- Select the unit's/organization's Service component from a drop-down menu that includes Joint Service, DoD, the Military Service Academies (MSA) and MSA Preparatory Schools, as well as active duty and Reserve options for the Army, Navy, Marine Corps, Air Force, Space Force, and Coast Guard.
- This information is used to pull appropriate language and Service-specific questions into the *DEOCS*.

- **Step 12 – Select the Command Level (if applicable).**

- This drop-down menu will present a list of command structures specific to the Army, Navy, Marine Corps, Air Force, Space Force, and National Guard.
- This information is used to help capture the structure and composition of units and organizations taking the *DEOCS*.


- **Step 13 – Select the Unit Type (if applicable).**

- **Step 15 – Enter the Unit/Organization Identification Code (Unit Identification Code (UIC), Reporting Identification Code (RUC), Personal Accounting Symbol (PAS), or Operational Facilities Code (OPFAC)).**

- UIC is for the Army, Navy, and the DoD.
- RUC for Marine Corps.
- PAS is for the Air Force and Space Force.
- OPFAC is for the Coast Guard.
- This information is used for trending *DEOCS* results over time and downloading past *DEOCS* results.

**Unit/Organization Identification Code (UIC/RUC/PAS/OPFAC) \***

There are many ways in which units and organizations are identified. In this field, enter the UIC, RUC, PAS, or OPFAC code that identifies the level at which you are registering your unit or organization's *DEOCS*. Use the full 5- or 6-digit UIC code, 5-digit RUC, 8-digit PAS code, or 5-digit OPFAC code assigned to your unit or organization.

- **Step 16 – Type the Installation, Base, Ship, or Location for the unit or organization.**
  - The searchable dropdown will display options as you type, and you can select an item once found. If the installation, base, ship, or location you are looking for is not on the list, you can manually add it by typing the full, official name directly into the field.
  - Include the name of the installation, base, ship, or location where the majority of the *DEOCS* participants work. For example, Fort Bragg, Pentagon, or Whiteman Air Force Base.
  - For National Guard, Reserve, or other (e.g., recruiting station) surveys where most survey participants are not located at a military installation, base, ship, or location, please search and select “Does not apply.”

#### Installation/Base/Ship/Location \*

Use the searchable drop-down menu below to identify the installation, base, ship, or other location where the majority of your survey participants currently work. You can search by entering text into the field or view all options by clicking on the field and scrolling through the list. If your installation, base, ship, or location is **not** listed, manually add it by typing the full, official name directly into the field or select “Does not apply” if applicable. Do not use acronyms. For National Guard, Reserve, or other (e.g., recruiting stations) units/organizations where the majority of your survey participants are not located at a military installation or base please search and select “Does not apply”.

- **Step 17 – Type the Unit’s or Organization’s Title.**
  - This field will be used throughout the *DEOCS* to keep participants oriented to thinking about their specific unit/organization, so ensure that this item is entered exactly as it should appear.
  - For example, a military unit that enters their Unit/Organization Title as “First Armored Division,” will be shown within the survey as follows:  
“Overall, how would you rate the current level of morale in your unit, First Armored Division?”

- **Step 18 – Enter the Unit’s or Organization’s City, State, and Zip Code.**
  - This information should reflect the location where the majority of the *DEOCS* participants work.

- **Step 19 – Select the unit’s or organization’s deployment status.**
  - This field is only applicable for Army, Navy, Marine Corps, Air Force, Space Force, National Guard, and Coast Guard. Please select “No” if not applicable for your Service component or if your unit or organization is not deployed.

- **Step 20 – Enter the Unit Commander’s or Leader’s Information for the unit or organization requesting a *DEOCS* and the date the commander or leader assumed command or their leadership role.**

- **Step 22 – Enter the Equal Opportunity Advisor’s (EOA) or Command Climate Specialist’s (CCS) Information for the unit or organization requesting a *DEOCS*.**
  - If the survey administrator is the EOA/CCS for the unit or if the unit does not have an EOA/CCS, click the check box.

- **Step 23 – Enter the Senior Non-Commissioned Officer's (NCO) or Senior Enlisted Leader's (SEL) information for the unit or organization requesting a DEOCS.**
  - If the unit or organization does not have a Senior NCO or SEL, click the check box.

- **Step 24 – Select the Start Date and End Date for the *DEOCS* in the “Survey Window” section.**
  - The annual fielding window for the *DEOCS* is from August 1<sup>st</sup> to November 30<sup>th</sup> and surveys must begin by October 31<sup>st</sup> per DoD Instruction 6400.11, DoD Integrated Primary prevention Policy for Prevention Workforce and Leaders. The start date will default to one week from the date the survey is being registered, but this date may be changed as needed.
  - When selecting a start date, ensure that adequate time is allowed for commander or leader review and approval of the survey request. The survey will not start until the commander or leader of the unit or organization has approved it. The commander or leader must approve the survey either from the e-mail they receive from the *DEOCS* system or by logging directly into the Portal.
  - The end date will default to four weeks from the start date, but this date may be changed as needed. Survey administrators can update the end date once a survey has started.
    - However, a survey cannot be re-opened once it has closed, so it is important to monitor response rates while the survey is still open and pro-actively extend the end date, if necessary.<sup>5</sup>
  - Start and end dates/times align with the North American Central Time Zone. Account for time differences when selecting start and end dates.

### Survey Window

The annual fielding window for the DEOCS is between August 1st and November 30th, and the latest a DEOCS should start is October 31st. If the unit/organization is completing the survey outside of the annual fielding window, a justification must be provided below.

Additionally, the DEOCS start date and end date times are based on the North American Central Time Zone (CT). Therefore, due to differences in time zones, please allow additional time as needed when selecting start and end dates.

- **Step 25 – Select a reason for requesting a *DEOCS* outside of the annual fielding window.**
  - This field is displayed when the survey window start date falls outside of that of the official annual fielding window. Selecting “Other” will generate a write-in response box where you can enter justification for your survey request date falling outside of the annual fielding window.

- **Step 26 – Enable or disable the Survey Window Automatic Extension.**
  - The *DEOCS* system has an automatic extension feature that, if selected during survey registration, will automatically extend the end date of the survey if the response rates are low. If you select this option, three days before your scheduled end date, if the response rate is less than 30% or fewer than 16 participants have taken the survey, the system will automatically extend the survey end date by one week. This automatic extension can happen up to two times.
    - To enable the automatic extension feature, leave the check box blank.
    - To disable the automatic extension feature, click the “Automatic extension opt out” check box.
    - The survey must field for at least 4 days to use the Survey Window Automatic Extension.

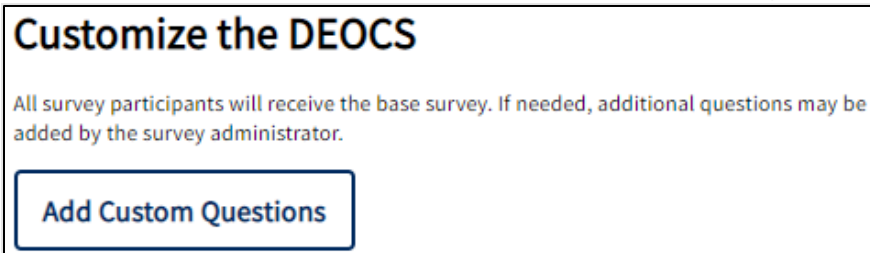

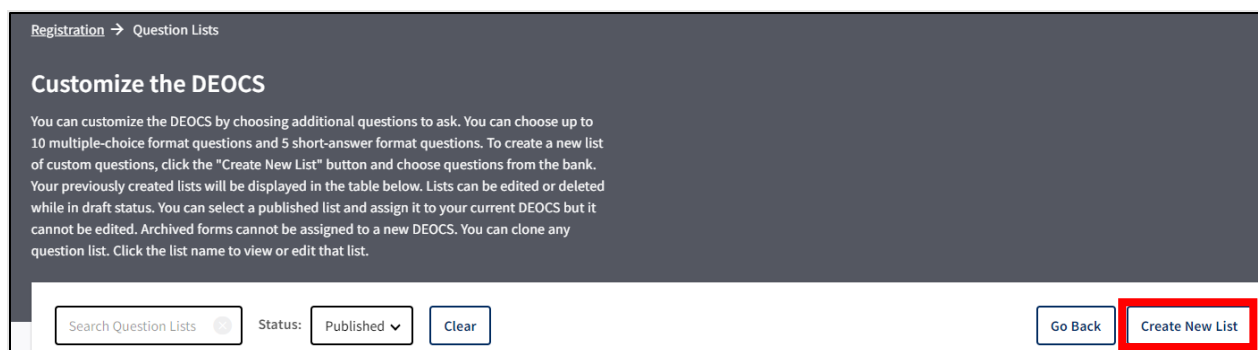
The system will monitor response rates for your survey. Three days before your scheduled end date, if your response rate is less than 30% or there are less than 16 participants, the system will automatically extend your survey end date by one week. This automatic extension will happen up to 2 times. [Click here](#) if you DO NOT want your survey to automatically extend. Please note you cannot reopen your survey once it closes.



- **Step 27 – Customize the DEOCS with closed-ended questions (LDQ) or open-ended questions (SAQ).**
  - Due to historical naming conventions, closed-ended questions are referred to as LDQs and open-ended questions are referred to as SAQs.
  - This optional step allows survey administrators to add additional questions to the *DEOCS*.<sup>6</sup> To customize the *DEOCS*, click “Add Custom Questions” and continue to Step 30. If you do not want to customize the *DEOCS*, skip to Step 37.
  - These are questions developed by the Office of People Analytics in accordance with stakeholders from the Service branches. Questions cover a wide variety of workplace and organizational climate topics.



- **Step 28 – Click the “Create New List” button.**
  - If you have already created and saved a list of custom questions for this administration or a previous administration, it will be displayed in the example table below under “Question List Name.” To use an existing list, click the check box next to the list’s name, click “Add List to Survey,” and skip to Step 36.

- **Step 29 – Enter a Question List Name.**

- Type in a name for the list to be created. It is recommended that an informative, descriptive name is used. Click “Save.” Question lists cannot be saved or added to a survey without a name.

- **Step 30 – Navigate to the LDQ List tab.**

- **Step 31 – Add closed-ended questions.**

- Clicking the “Add Questions” button displays a pop-up menu with a list of LDQs.
  - Survey administrators may browse the questions by scrolling, search the questions by entering keywords into the “Search Questions” field, or filter the questions by category using the “Category” drop-down menu. You can clear any filters and searches by using the “Clear” button.
  - You can select up to ten LDQs by using the “Add” button to the left of each question. The number of LDQs currently selected will be displayed in the header next to “Selected LDQ Questions.” This header can be clicked on to view the selected questions.
  - You can remove LDQs by navigating to the “Selected LDQ Questions” tab and clicking the “Remove” button to left of each question.
  - Click “Add Questions to List” after selecting the desired LDQs.

- LDQs will be administered to DEOCS participants in exactly the order displayed here. To reorder their presentation, click “Reorder Questions” and use the arrow buttons or edit the number beside each question.
- If the maximum number of ten LDQs has been exceeded, a warning message will appear in red in the header and the list will not be able to be saved, published, or have additional questions added until the appropriate number of questions has been removed.

• **Step 33 – Add open-ended questions.**

- Clicking “Add Questions” displays a pop-up menu with a list of SAQs.

## Edit a *DEOCS* Request

Depending on the status of the survey request, survey administrators can edit certain fields in the “Survey Details” tab (see table below). This section provides survey administrators with an overview of which information can be edited and when. To edit a *DEOCS* request survey administrators should follow these steps:

- **Step 1 – Navigate to the “View Existing Survey Requests” page.**
- **Step 2 – Locate the appropriate *DEOCS*.**
  - Using the filters at left, locate the *DEOCS* to be edited. Click anywhere on the *DEOCS* registration to be taken to the Survey Details page.
- **Step 3 – Use the table below to guide edits.**
  - The table describes which fields can be edited during each survey status type. Once finished, click the “Done” button to return to the main page and view other surveys if needed.

- **Step 4 – Make any necessary edits.**
  - Scroll to the appropriate location in the *DEOCS* registration make the required edits.
- **Step 5 – Click the “Done” button.**
  - You will return to the main page to view other surveys, if needed.

## Cancel a *DEOCS* Request

Survey administrators may cancel a *DEOCS* at any time **before the start date**. This section will provide an overview of when a *DEOCS* may be canceled, as well as step-by-step instructions for canceling a *DEOCS*.

### Survey Status and Cancellation

- **If a *DEOCS* is in “Ready for Approval” status:** A survey administrator can cancel the *DEOCS*. If the commander or leader tries to approve the survey without knowledge that it has been cancelled by the survey administrator, the commander or leader will receive a message saying the survey can no longer be approved because it was cancelled.
- **If a *DEOCS* is in “Approved” status:** A survey administrator can cancel the *DEOCS* any time before the start date. The “cancel survey” button will only appear before the start date has been reached.
- **If a *DEOCS* is in “Denied” status:** No action is needed to cancel the *DEOCS*. The survey will not start until it has been approved by the commander or leader.
- **If a *DEOCS* has already started:** A *DEOCS* that is already started cannot be cancelled, but a new end date can be selected to close a *DEOCS* early. To close a *DEOCS*, survey administrators can change the end date to today’s date in the Survey Details tab (noted in step 24). The survey system will continue to allow participants to take the survey until the end of the day and will then close out the survey.



## Steps to Cancel a *DEOCS*

- **Step 1 – Log in to the *DEOCS* Portal [here](#) and Select “Survey Registration.”**
  - This page can be accessed from two locations: in the main body of the page under “Survey Administrator” and in the top menu under “My Applications.”
  - Please use Google Chrome, Mozilla Firefox, Microsoft Edge, or Apple Safari. Internet Explorer is not a supported browser at this time.
- **Step 2 – Locate the appropriate *DEOCS*.**
  - Using the filters at left, locate the *DEOCS* to be edited. Click anywhere on the *DEOCS* registration of interest. This will bring up the Survey Details page that contains all the registration information.

## Next Steps after Registering a New Survey

This section provides a brief overview of the next steps in the *DEOCS* process and associated resources (in footnotes).

- After successfully registering a *DEOCS*, user accounts are automatically created for the commander or leader of the unit or organization and their supervisor. The commander or leader and their supervisor will also receive an automated e-mail letting them know about the request. The commander or leader will need to approve the *DEOCS* request before the survey can start.<sup>7</sup>
- Once the commander or leader has approved a survey request, the survey administrator will receive an e-mail with information and instructions on how potential participants can access the survey. If the commander or leader rejects the survey, the survey administrator will be sent an e-mail with the reason for the denial. The survey administrator can then edit any survey details as needed and resubmit it for approval.
- While the survey is in the field, it is important to monitor response rates and conduct survey outreach, if necessary.<sup>8</sup>
- When the survey closes, *DEOCS* results will be made available in the *DEOCS* Interactive Dashboard within two weeks. The survey administrator, commander or leader, and their supervisor will receive an e-mail notification when the results are ready.<sup>9</sup>
